## **Amendment 5: TERMS OF APPOINTMENT**

The NASAA Constitution currently states that Directors (member elected and Board appointed Directors) shall hold office until the annual general meeting three years after his or her appointment.

The Vuca Governance review recommended that NASAA should consider that Directors should have a maximum term of appointment.

Terms of appointment were considered to ensure continuity of Board corporate knowledge and also to ensure opportunity for Board renewal. Once a Director has served their tenure they may renominate for the NASAA Board after standing down for one Director term of appointment.

Options include for Director terms of tenure:

- 1. Three terms of two years (Total 6 years)
- 2. Three terms of three years (Total 9 years)
- 3. Four terms of two years (Total 8 years)
- 4. Two terms of Four Years (Total 8 years)
